

2.1 Project Summary

Substance use is a severe problem in Albania, but can be prevented. The project will use evidence-based prevention strategies to reduce the prevalence of substance use among youth in Albania and empower them to make healthy choices. The project will also create a supportive environment for children in Albania, where they feel safe and supported to make healthy choices.

Albania has a high prevalence of substance use among young people. The most commonly used drugs are cannabis, tobacco, and alcohol. Young adults, particularly males, are likelier to use illegal drugs, including cannabis and cocaine. Substance use also extends to adolescents, with an increasing trend in illegal drug use and cannabis use among 15- to 16-year-old students. According to a 2019 survey, 20% of young people in Albania have used drugs at least once, and 7% have used drugs in the past month. According to the HBSC study in 2018, the lifetime use of cannabis among school-age youth in Albania was about 5% (2% in girls vs. 9% in boys). Similarly, according to the ESPAD study 2015, about 7% of young people had tried cannabis at least once in their lifetime (12% of boys vs. 2% of girls).

• According to a 2014 survey, 7.9% of 15- to 34-year-olds in Albania reported using cannabis in the last year.

- The prevalence of cocaine use is lower, at 3.6%.
- There is also a high prevalence of high-risk drug use, such as injecting drug use.
- In 2015, there were an estimated 6,182 problem drug users in Albania, of whom 60% used drugs by injection.
- This increases drug-related infectious diseases, such as HIV and hepatitis C.
- In 2015, 2 new HIV cases in Albania were attributed to injecting drug use.
- The prevalence of hepatitis C among people who inject drugs is estimated to be 28.8%.

The prevalence of high-risk drug use, notably regular opiate use, is also concerning, with an estimated 6,182 opiate users in Albania. Many of these high-risk users inject drugs daily, exacerbating health issues and spreading infectious diseases. While the number of HIV cases linked to drug injection remains small, Hepatitis B and C prevalence among people who inject drugs (PWID) is high. The data highlights the severe and multidimensional health concerns tied to substance use, including the risk of transmission of infectious diseases. The prevention interventions, like school-based programs and family skills training, are mainly universal strategies with sporadic execution and focus primarily on urban areas. The prevalence of drug use and related harms underscores the need for a comprehensive, targeted approach to substance use prevention and harm reduction, particularly for vulnerable and high-risk groups.

Albania's lack of comprehensive and effective substance use prevention programs is a significant problem.

• There is a lack of awareness of the risks and consequences of substance use among young people in Albania.

• There are few school-based prevention programs, and those that exist are often not well-implemented.

• There are also few community-based prevention programs, and those that exist are often not well-funded.

The high prevalence of substance use among young people in Albania is a serious problem

with many negative consequences. These consequences include:

- Increased risk of addiction
- Increased risk of health problems, such as HIV/AIDS, hepatitis, and mental health problems
- Increased risk of accidents and injuries
- Increased risk of dropping out of school and unemployment

The project's specific objectives

The specific objectives of the project are to:

• Increase knowledge of the risks and consequences of substance use among youth in target areas by 50%.

- Provide young people with the skills and knowledge they need to make healthy decisions about substance use.
- Empower young people to be effective prevention advocates in their communities. The project will focus on several evidence-based prevention strategies, including:

• Educational programs that teach youth about the risks and consequences of substance use.

- Skill-building programs that teach youth how to resist peer pressure and make healthy choices.
- Support youth groups with alternative activities like yoga, mind games, etc., for youth who are most at risk from substance use.
- Peer Education approach and non-formal education.
- Youth Leadership in drug prevention

The project will also work to create a supportive environment for youth in target areas, where they feel safe and supported to make healthy choices. This will involve working with schools, families, and communities to create policies and programs that promote healthy lifestyles.

The project will be implemented over a period of 90 months and will reach directly a total of 300 young people. The project is expected to significantly impact the lives of young people in the community by reducing their risk of substance use and empowering them to make healthy choices.

Activity 1. Official opening and presentation of the project:

Activity 1.1 - 4 meetings in the schools and universities targeted by the project: Two meetings will be organized for each city, where the details of the project will be presented and how the project will help young people understand and combat drugs. Teachers, parents, and school and university staff will learn how to engage with this issue. In both cities, a university and a high school will be involved.

Activity 2: Empowerment of the capacities of student government members

Activity 2.1 – Designing an effective "Peer to Peer" program for drug prevention and promoting healthy behaviours among young people: An expert team will create a program on drug prevention that student government members can implement in their learning and studying environments. This will be the first step towards unifying a common program for all student government structures at the national level.

Activity 2.2 - 2 two-day training sessions for student government structures in 2 cities: Training to strengthen students' abilities to combat drugs in their communities through nonformal and peer education.

Activity 3: Drug Prevention Initiative: 2 drug use prevention initiatives will be supported with small grants for 2 groups from both cities to implement their original ideas, including a podcast/ mural/ storytelling/ short film, etc. The project will support students and their teachers eager to undertake an initiative to promote and educate on the topic through art. The project aims to encourage students' artistic expression by offering these small support funds, increasing awareness and understanding of drug use prevention and its consequences. The selected projects will be powerful tools to engage and educate the audience on this important topic. Through their creative efforts, young people will promote positive attitudes, break stigmas, and disseminate accurate information.

Activity 4: The first Youth Forum for Drug Prevention: This forum will bring together young people from all over Tirana and Elbasan, experts, youth organizations, representatives of responsible institutions, academia, and other actors to discuss drug prevention and how to combat this problem in their communities.

Activity 5: Creation of the online window/platform "RAPID" - An online platform that will provide information and resources for drug prevention among young people and important information for parents and teachers.

The alignment of these activities with the project objectives and expected outcomes is clear. Each activity is designed to increase knowledge about substance use, equip young people with the necessary skills to make healthy choices and empower them to become active participants in their communities' prevention efforts. The overall impact of these efforts is expected to be a significant decrease in substance use among young people and a shift in community attitudes and behaviours towards healthier lifestyles.

Some of the evidence-based prevention interventions and policies that the project will utilize:

• Educational programs using Peer -to -Peer Aproach: These programs will teach youth about the risks and consequences of substance use and skills for resisting peer pressure and making healthy choices. The programs will be tailored to the specific needs of Albania youth and delivered in various settings, such as schools, community centres, and online.

• Skill-building programs will teach youth to set boundaries, manage stress, and cope with difficult emotions. They will also teach child how to develop healthy relationships and lifestyle choices. The programs will be delivered by trained facilitators based on evidence-based interventions.

• Support youth groups: These groups will provide a safe and supportive space for youth struggling with substance use or at risk of using substances. The groups will offer peer support, information, and resources to help youth get help and stay sober. The groups will be led by youth and will be supported by trained facilitators.

• Alternative activities: These activities will provide youth with alternative activities, such as sports, arts, or music. These activities could help youth to stay busy and avoid using substances. The activities will be tailored to the interests of youth in Albania and will be available in various settings.

• Policy advocacy: The project will advocate for policies that support youth at risk of substance use. This could involve working with policymakers to create policies that promote healthy lifestyles or to make it more difficult for young people to access substances. These are just a few evidence-based prevention interventions and policies the project will utilize. The project will also work to create a supportive environment for youth in target areas, where they feel safe and supported to make healthy choices. Regarding policies/strategies the project will utilize:

• The Law on Prevention and Control of Substance Abuse: This law was adopted in 2007 and provides a framework for preventing and controlling substance abuse in Albania. The law defines substance abuse, sets out the responsibilities of government agencies and other stakeholders, and provides for developing prevention programs.

• The National Strategy for Prevention and Control of Substance Abuse: This strategy was developed in 2015 and sets out the priorities for preventing and controlling substance abuse in Albania from 2015-2020. The strategy focuses on five key areas: prevention, treatment, harm reduction, law enforcement, and research.

• The National Action Plan for Prevention and Control of Substance Abuse: This plan was developed in 2016 and provides a more detailed implementation plan for the National Strategy for Prevention and Control of Substance Abuse. The plan sets out specific goals and objectives for each of the five key areas and a timeline for implementation.

• The Ministry order for the organization and functioning of the student government, namely instruction no. 22, dated 4.10.2019, of the Minister of Education, Sports and Youth, "for the organization and functioning of the student government".

The Project will target youth as beneficiaries and how they will be actively engaged in the development and implementation processes:

• The project will work with youth-led organizations and networks to ensure that the project is responsive to the needs of youth. Youth Voice Network of Organisations is a youth organisation that young people and targets young people lead. Most partners are youth organisations, youth groups, peer educators and youth workers.

• The project will provide opportunities for youth to be actively involved in the development and implementation of the project. This project is designed by Young people and the core staff for the implementation will be young people. YVNO has submitted before a concept note about this project at UNODC but is was not selected.

• The project will create a supportive environment where youth feel safe and supported to share their experiences and ideas. This will involve creating a space where youth feel comfortable talking about substance use and feel their voices are being heard.

• The project will provide youth with the skills and knowledge they need to make healthy choices about substance use. This will involve providing youth with information about the risks and consequences of substance use and skills for resisting peer pressure and making healthy choices.

• The project will connect youth with resources and services that can help them if they are struggling with substance use. This will involve connecting youth with health services, support groups, and other resources.

By targeting youth as beneficiaries and actively engaging them in the development and implementation processes, the project will be more likely to be successful in preventing substance use among youth in target areas. Some specific actions taken into consideration by the project:

Firstly, youth empowerment is a crucial part of the project's design. The goal is to enable young people to understand the risks associated with drug use and equip them with the necessary tools to combat this issue in their communities. The project actively involves young people in raising awareness about drug prevention by providing small grants to support original initiatives such as podcasts, murals, storytelling, short films, etc. This encourages engagement, developing new skills, and

expressing personal experiences and perspectives.

Moreover, creating the online platform "RAPID" and the Youth Forum for Drug Prevention will serve as spaces where young people can access information, share their experiences, and engage in meaningful discussions about drug prevention.

The project's design also considers the diversity of young people. Activities will take place in both urban and tourist cities, ensuring that a wide range of young people, regardless of their backgrounds, can participate and benefit from the project.

Expected Outcomes:

1. Enhanced Knowledge and Skills: The student government members will acquire the knowledge and skills necessary to handle drug-related issues in their communities, contributing to drug prevention efforts.

2. Nationwide Uniformity: The development of a common program for all student government structures at the national level will bring about uniformity in strategies and actions taken against drug abuse.






